RE: Suggested amendments to the GSC Constitution

And GSC By-Laws

Most esteemed GSC Executive Committee members, Directors, and the GSC Senate,

Both the GSC Constitution and By-Laws regarding the order of succession of the GSC Executive Committee currently allow for only the Vice President of Administration and Finance to succeed the GSC President, should the president no longer be fit or eligible to serve in the role as president. I propose the following changes to each document extending and adding the responsibility of succession to the Vice President of Programming and the Vice President of Communications, should the need ever arise. The addition will be made in each document, as required by the Constitution and By-Laws. Each suggested change consists of the addition of new language in red.
