Most Esteemed GSC Senators,

The GSC President and Executive Committee is requesting the following corrections, additions, and clarifications to both the GSC Constitution and By-Laws. Please note in the copies of both documents sent via email, the strike outs are the verbiage being **removed** and the additions or corrections are in red.

The changes being requested are generally cleaning up the language in both documents and consolidating two directorships, Internal and External relations into one directorship titled "Director of Outreach".

Second, clarification of the term of office for the Executive committee members is made. Their office terms are set at June 1 through May 31 of the succeeding year.

Third, clarification is added to the Constitution concerning eligibility of Graduate Students as members in the GSC.

Fourth, in the By-Laws, the GSC President is included as a potential attendee to Election committee meetings.

Attendance at this meeting is of the utmost importance, as changing our governing documents is an important obligation of the GSC Senate.

The Executive Committee will be providing snacks and the new GSC t-shirts. Those who attend online will need to make arrangements to either pick up their shirts or receive them by mail.

As a quick reference, the following corrections and clarifications were made to the GSC Constitution:

1. The text below is being added to the Membership Criteria:

Article III—Non-Discrimination Statement and Membership Criteria

Section 2-Membership Criteria

Membership in this organization is limited to any graduate student who is currently enrolled at the University of North Texas. Active membership in this organization will be extended to graduate students who are part of any of the 3 branches of the graduate student council and the graduate students who are actively involved in any of the graduate student council events/meetings.

2. The following consolidation and correction is made to combine the External Relations and Internal relations Directorships into one Directorship of Outreach:

The following corrections, additions, and clarifications to the GSC By-Laws are suggested by the GSC Executive Committee:

As a quick reference, the following corrections and clarifications were made to the GSC By-Laws:

Article II. Nominations, Elections and Appointments of Executive Committee

Section 4:

E. The term of office for the Executive committee shall be June 1st through May 31st of the following year.

Section 4. Director Appointments

A. All elected Executive Committee members, except the President, shall appoint a Directoror Directors no later than the end of the first month of their term.

- A. The VP of Administration and Finance shall appoint a Director of Administration.

B. The VP of Communications and Marketing shall appoint a Director of Communicationsand a Director of Marketing.

C. The VP of Programming and Outreach shall appoint a Director of Programming, a Directorof Internal Relations, and a Director of External Relations.

- C. The VP of Programming and Outreach shall appoint the Director of Programming and the Director of Outreach.
- D. The Parliamentarian shall appoint a Director of Legislative Affairs.

E. All Directors shall be confirmed by the President no later than one week following their appointment by their respective VPs.

Article III. Duties & Responsibilities of GSC Leadership

Section 1: Executive Committee

a. Reports directly to the Vice President of Programming and Outreach

B. Director of Internal Relations

a. Responsible for fostering relationships with parties within the university including but notlimited to student organizations that serve graduate students, Student Government Association-(SGA), and faculty and administration.

C. Director of External Relations

 Responsible for fostering relationships with outside parties including but not limited tograduate student governments at other universities, local businesses, and elected officials.
Reports directly to the Vice President of Programming and Outreach

- K. Director of Outreach
 - a. Responsible for fostering relationships with both entities outside and inside the University.
 - b. Reports directly to the Vice President of Programing and Outreach.

Article V. Rules on the GSC Senate

Section 3: Senate Standing Committees C- External Relations Committee Public Relations Committee

Article VIII. Removal of GSC Leadership

Section 1. Removal or Resignation of Executive Committee Members

D. The President shall accept the resignation of executive committee members. The executive committee member will remain in their elected position until the resignation is accepted by the GSC President.

F. The President and/or Executive Committee, on removal or resignation of an Executive Committee member, shall nominate within 14 days a qualified person to serve in the position on an interim basis, subject to approval by a two-thirds (2/3) majority of the Senate.

Article XI: Election Code

Section 2: Election Board

G. All Election Board meetings will be open only to Election Board, the GSC President, if not running as a candidate, members and the GSC Advisor. The Board shall keep written minutes of all meetings, including hearings. Quorum for all Board meetings, including election certification meetings, shall be defined as three Board members plus the Election Commissioner.

Instructions for action:

The proper format of the motion to accept the proposed changes for the GSC Constitution is:

"I make the motion the proposed changes to the GSC Constitution be approved/denied."

The proper format of the motion to accept the proposed changes to the GSC By-Laws is:

"I make the motion the proposed changes to the GSC By-Laws be approved/denied."

Both motions will need to be independently seconded and then voted on.

Either motion can be modified to pass or deny any of the items. If you wish to make such a motion, I will be glad to help you do so during the meeting.

The vote to pass the changes in the GSC Constitution will be 3/4 of the Senators in attendance.

The vote to pass the changes in the GSC By-Laws will be 2/3rds of the Senators in attendance.
