- a. ~~Assists in identifying and maintaining partnerships with organizations within the university and Denton communities~~ **Responsible for fostering relationships with parties within the university including but not limited to student organizations that serve graduate students, Student Government Association (SGA), and faculty and administration.**
- b. Reports directly to the Vice President of Programming and Outreach.

L. **Director of External Relations**

- a. **Responsible for fostering relationships with outside parties including but not limited to graduate student governments at other universities, local businesses, and elected officials.**
- b. **Reports directly to the Vice President of Programming and Outreach.**

M. **Director of Legislative Affairs**

- a. **Responsible for staying abreast of UNT policies as well as state and federal laws, and for providing the legal framework for GSC initiatives and for meetings with administration.**
- b. **Help establish the priorities for programming at Legislative Action Day events and for discussions with elected officials.**
- c. **Reports directly to the Parliamentarian.**
